
31st August 2019 - Knowledge Series 1

The practical aspects of dealing with natural disaster, recovery efforts, insurance coverage, claim process and accounting treatment were well deliberated. The participants thoroughly enjoyed the knowledge sharing session.






**20th November 2019 - Handle Stress Management from Dawn to Dusk
